FOREWORD

I am happy to know that my Ministry is bringing out a series of Statewise booklets on the achievements of the Government of India, in the Ministry of Tribal Affairs (MoTA) in the last few years, pertaining to the empowerment, welfare and development of our Scheduled Tribe brethren and sisters.

The fifth edition in this series pertains to the State of **Telangana**. Apart from facts regarding the Scheduled Tribes (STs) of the State, this booklet is a wealth of information on the schemes of the Ministry as implemented in Telangana.

The flagship Eklavya Model Residential School (EMRS) Scheme has been a transformative change, since its introduction, with both the cost of construction and the per student recurring cost being increased exponentially. Further, the ensured that these schools strive to impart quality education at par with the best institutions in the country.

Our Scholarship schemes have seen a rise in the number of children availing them. Further, digitization and the release of funds in the Direct Benefit Transfer (DBT) mode to students has considerably streamlined the processes and made them transparent. It is a matter of pride to note that the Ministry grants scholarships to around thirty four (34) lakhs pre-matric and post-matric students on universal coverage basis subject to income criteria to ST students, besides granting two other kinds of scholarships to meritorious students on selection basis. Indeed, the scheme of scholarships for students studying in selected top institutions of the country, which was previously granted on selection basis, has also been now opened up on universal basis subject only to income criteria.

Additionally, the Ministry and its organizations, the Tribal Cooperative Marketing Development Federation of India (TRIFED) and the National Scheduled Tribes Finance Development Corporation (NSTFDC), are engaged in a variety of ways to ensure livelihood of the tribals, especially women. The TRIFED, for instance, strives to ensure Minimum Support Price (MSP) for Minor Forest Produce (MFP) as well as the formation of the Van Dhan Vikas Kendras, besides serving as a marketing platform for the tribal

products. The Pradhan Mantri Janjatiye Vikas Mission (PMJVM) (a revamped scheme by the merger of the earlier two schemes of (i) Institutional Support for Development and Marketing of Tribal Products/produce and (ii) Mechanism for Marketing of MFPs through MSP and Development of Value Chain for MFP) has revitalized tribal livelihood sector. Van Dhan Vikas Kendras and the other components of the PMJVM have shown the acumen of the tribal MFP collector, craftsmen, artisans and entrepreneurs. The Ministry is therefore eager that many more such Kendras and enterprises should be set up and thrive to showcase the enterprise and skills of the tribals.

The NSTFDC offers credit to eligible tribal entrepreneurs at considerably lesser interest rates as well as student loans. This booklet is an important document at creating awareness on such schemes.

Multi-sectoral activities projects have been funded by the Ministry under grants under Article 275(1) of the constitution, the erstwhile Special Component Assistance (SCA) to Tribal Sub-Scheme (which is also now revamped as the Pradhan Mantri Adi Adarsh Gram Yojana) and the scheme for Comprehensive Conservation and Development of the Particularly Vulnerable Tribal Groups (PVTGs). Telangana has benefitted out of such schemes and we hope will continue to be a partner in this Ministry's goals of development of the tribals.

The tribal Research Institutes (TRIs) are an important part of our journey. They serve as our sources of knowledge for understanding of the tribal people for effectively administering our schemes as well as in preservation, conservation and promotion of tribal socio-cultural life and livelihoods. I am happy to report that the construction of the building of the Tribal Research Institute of Telangana at Hyderabad has been supported by my Ministry.

Where the Government schemes are unable to penetrate some tribal areas the scheme of Grants to Voluntary Organizations, especially in the Health and Education sectors has helped many tribal communities. Likewise, our Centers of Excellence have taken up projects in may areas, including research pertaining to STs.

Constitutional and legal matters are of especial significance to our tribal population. The Konda Reddis, a tiny community in numbers, but signifying our Government's resolve of *reaching out to the last mile*, has been notified in the list of Scheduled Tribes of Telangana recently. This is one amongst other communities in other States who have been similarly notified.

The Forest Rights Act (FRA), 2006 has been rightly hailed as an Act to undo the historical injustice done to the tribal population. It uniquely recognizes the symbiotic relationship between the forests and the tribes. The Ministry has taken significant steps to ensure the implementation of the Act. Telangana's achievements in this respect have been documented herein.

Last, but not the least, in order to recognize the unsung tribal heroes who has notified 15th November, the birth anniversary of Bhagwan Birsa Munda, as Janjatiya Gaurav Diwas in 2021. I am happy to note country-wide celebrations, including in Telangana, of this day in both 2021 and 2022.

The Ministry is also well aware that the tribals have a unique culture and character that enable them to live a satisfactory life, despite many hardships. There are indeed numerous lessons in climate action, living life to the fullest and in attaining happiness, to strive to attain its objectives of bringing the tribal population of this country on per with the national and global best, while also learning and disseminating the best practices, traditional knowledge and wisdom that these diverse communities have to offer to the nation and the world. This shall be done in partnerships with stakeholder, with a shole of the nation approach, with the goal of attaining sabka saath, sabka vikas, sabka vishwas, sabka prayas.





EKLAVYA MODEL RESIDENTIAL SCHOOLS (EMRS) SCHEME

Highlights of Scheme

- ⇒ EMRS started in 1997-98 to impart quality education to ST children. Carved out as a separate scheme in 2018-19
- Caters to students from Class 6 to 12
- → 480 students per school
- → Initially funded under Article 275 (1)
- → 740 (452 new + 288 old) EMRSs to be set up by 2026.
- → Upgradation of 211 old schools @ Rs 5 Cr. per school
- → Setting up of 15 CoEs in sports @ Rs 5 Cr. each
- → Approval of Rs. 28919.72 crore for the period 2021-22 to 2025-26.

Budget Announcements

2018-19:

"Every block with 50% or more ST population and 20,000 or more tribal persons to have an EMRS. Schools to be on par with JNVs"

2021-22:

"Propose to increase the unit cost of each such school from Rs. 20 crores to Rs. 38 crores, and for hilly and difficult areas, to Rs.48 crores. This would help in creating robust infrastructure facilities for our tribal students:

The Ministry is implementing 5 scholarship schemes namely pre-matric scholarship, Post-Matric scholarship, National fellowship, National Scholarship and National Overseas Scholarship.

- Van Dhan Kendras being established across country

Pradhan Mantri Janjatiya Vikas Mission in TELANGANA

- ➡ Ministry is implementing the scheme 'Pradhan Mantri Janjatiya Vikas Mission (PMJVM)' with a total financial outlay of Rs. 1612.27 crore for implementation during the financial years 2021-22 to 2025-26. PMJVM has been redesigned through merger and extension of two existing schemes for promotion of tribal livelihood, i.e., "Mechanism for Marketing of Minor Forest Produce (MFP) through Minimum Support Price (MSP) and Development of Value Chain for MFP" and "Institutional Support for Development and Marketing of Tribal Products / Produce". Tribal Cooperative Marketing Development Federation of India (TRIFED) is the nodal agency for implementation of the Scheme. PMJVM envisions to strengthen tribal entrepreneurship initiatives and to facilitate livelihood opportunities by promoting more efficient, equitable, self-managed, optimum use of natural resources, Agri / Non-Timber Forest Products (NTFPs) / Non-farm enterprises. The Mission seeks to support the theme of "Vocal for Local by Tribal".
- ▶ In Telangana significant milestones have been achieved in the implementation of the Van Dhan Vikas Kendra (VDVK) initiative, as evidenced by the sanctioning of funds amounting to 225 Lakhs for the establishment of 17 VDVKs. These centers have had a profound impact, engaging a total of 5100 beneficiaries in various tribal communities. In a concerted effort to enhance the capabilities of these VDVKs, 17 centers have received comprehensive training sessions and essential tool kits.



Van Dhan Vikas Karyakram (VDVK)

Playing important role in economic development of tribals.

Structure

- TRIFED-nodal agency for implementation of VDVK component under the scheme of 'PMJVM'.
- VDVK- common facility centres for procurement cum value addition of tribal products/ produce.
- Each VDVK SHG 20 Members
- 15 VDVK SHGs (300 members) form a Van Dhan Vikas Kendra (VDVK)
- Robust Governance mechanism State Nodal Department, State Implementation Agency and Mentoring agencies.

Activities

- Rs.15 Lakhs Central grant provided to SIA through TRIFED for VDVK promotion, training and equipment support.
- VDVKs Tribal Start-Ups for Value addition, packaging, marketing and branding
- Digitalization of all tribal beneficiaries, VDVK SHGs and VDVKs through mobile App and GIS.
- Empanelment of VDVKs through quality checks, sales through TRIFED 'tribe india' outlets and e-commerce platforms: Tribe India, Amazon, Snapdeal, Flipkart etc.

Equity Support to NSTFDC/STFDCs;



Term Loan

- For viable schemes costing up-to 50.00 Lakhs per unit
- Up-to 90% assistance from NSTFDC and balance is met by way of subsidy/ Margin Money etc
- Interest rates vary between 6-8-10%



Adivasi Mahila Sashaktikaran Yojana (AMSY)

- An exclusive scheme for ST women
- Financial Assistance up-to 90% for schemes costing up-to 2 lakh
- Highly concessional interest rate of 4% p.a.



Micro Credit Scheme

- For meeting small financial requirements of members of ST SHGs
- Financial assistance up-to Rs. 5.00 Lakhs per SHG with ceiling of Rs. 50,000/- per member
- Interest rate is 6% p.a.



Adivasi Shiksha Rrinn Yoiana

- To meet the expenditure for pursuing technical and professional education including Ph.D. in India by ST students
- Upto 90% assistance from NSTFDC, subject to maximum loan of Rs 10 Lakhs per family @ 6%

Major Achievements:

Telangana: In Telangana, while not initially mentioned, has also witnessed substantial financial assistance. The Term Loan scheme in the state has seen a disbursement of ₹ 975.76 Lakhs, benefiting 5211 individuals. The Micro Credit Scheme, on the other hand, recorded a remarkable disbursement of ₹ 35296.23 Lakhs, reaching 110316 beneficiaries.

- → The FRA, 2006 has provisions for recognition and vesting of forest rights and occupation in forest land in forest dwelling Scheduled Tribes (FDSTs) and other traditional forest dwellers (OTFDs).
- → As per FRA and rules made thereunder, the responsibility for implementation of the Act lies with State Governments/UT Administrations.
- → As on June, 2023, a total of 45,54,603 claims 43,68,025 individual and 1,86,578 community) have been filed under FRA 2006 and 23,12,041 titles (22,01,842 individual and 1,10,199 community) have been distributed to the extent of 1,77,90,056 acres (47,56,040 acres for individual and 1,30,34,016 acres for community) of forest land.
- Ministry of Tribal Affairs provides necessary support to the States / UTs for implementation of FRA as and when asked for.
- Joint Communication has been issued by Secretaries of Ministry of Tribal Affairs and Ministry of Environment, Forest and Climate Change for implementation of the FRA, 2006
